### Section 4. First Aid Measures

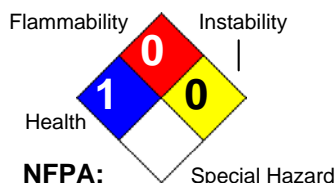
