GENERAL INFORMATION

Harvest Plus TC is a mixture of macro- & micronutrients that can be applied as a foliar application, soil, side-dress and through irrigation.

DIRECTIONS FOR USE

Crop yield / plant growth may be compromised if the product is not used according to label directions.

RECOMMENDED USES

FOR SOIL APPLICATION: For uptake in the root zone of the plant, use one or more applications of **Harvest Plus TC** through the irrigation system at 1 to 2 quarts per acre as needed. Repeat applications can be made every 7-14 days.

FOR IN-FURROW APPLICATION: Apply 1-2 quarts in the seed furrow or banded 2x2 alongside the seed furrow. May be mixed with starter fertilizer solutions. It is recommended to conduct a compatibility test prior to mixing into large volumes of fertilizer.

FOR SIDE-DRESS APPLICATION: For uptake in the root zone of the plant, use 1-4 quarts mixed into fertilizer side-dress solution. Jar test fertilizer and **Harvest Plus TC** to ensure compatibility.

FOR FOLIAR SPRAY APPLICATION: Apply 1 to 2 quarts per acre. For ground applications use water carrier volume of 10 GPA minimum or 5 GPA for aerial applications. Do not exceed 1 quart per 5 gallons water used as carrier.

Use **Harvest Plus TC** at the recommended rate on the following crops:

FIELD CROPS: Alfalfa, bean crops, canola, clover, corn, cotton, flax, forage grasses, peanut, potato, rape (canola), rice, sorghum, soybean, sugar beet, sugarcane, sunflower, tobacco, and wheat, barley, oat, or other cereal grain.

VEGETABLE CROPS: Artichoke, asparagus, broccoli, cauliflower, cabbage, kale, and other cruciferous vegetables; leaf lettuce, head lettuce, dandelion, radicchio, and other leafy vegetables; cucumber, melon, pumpkin, squash, and other cucurbits, onion, garlic, and other bulb vegetables; tomato, pepper, eggplant and other fruiting vegetables; strawberry; carrot, sweet potato, radish, beet and other root and tuber vegetables.

MIXING INSTRUCTIONS: Follow this mixing order - (1) Fill tank ½ full of water. (2) Add water conditioner adjuvants and other tank mix adjuvants (as needed), agitate. (3) Pour in desired rate of **Harvest Plus TC**, continue agitation. (4) Add other tank mixing ingredients as per label, continue agitation. (5) Finish filling tank.
