GENERAL INFORMATION

PURPOSE: CHARGE 12% is manufactured by a unique patented process which extracts humic acids directly from Leonardite. CHARGE 12% is an aqueous dispersion of humic and related acids and can be tank mixed with most pesticides, herbicides, defoliants and liquid, soil and foliar fertilizers including acid fertilizers. CHARGE 12% dilutes readily with water for spray, dribble or injection applications in irrigation systems. Charge 12% may alter the soil or other medium in such manner that the physical and biological properties are materially enhanced. CHARGE 12% is not a plant food but may increase micronutrient uptake.

DIRECTIONS FOR USE

Crop yield / plant growth may be compromised if the product is not used according to label directions.

Keep the lid on tight when not in use.

SHAKE OR STIR WELL BEFORE USING

RECOMMENDED USES

FOR USE ON THE FOLLOWING CROPS:

Alfalfa, almonds, avocados, apples, barley, beans, broccoli, cabbage, cauliflower, carrots, celery, citrus, corn, grapes, lettuce, milo, melons, nectarines, rice, pears, peaches, pecans, peppers, peanuts, pineapple, potatoes, sorghum, soybeans, sugar beets, sweet corn, sugar cane, strawberries, tomatoes, turnips, walnuts, watermelons, wheat and most other crops.

When spraying always use slotted screen or 50 mesh or larger in line and nozzles.

BROADCAST APPLICATION: Apply on soil surface prior to planting at 2 quarts per acre (4.4 liters per hectare). Can be applied with liquid fertilizer.

IN-ROW APPLICATION: Apply at 1 quart per acre (2.2 liters per hectare) on the seed at planting. Can be applied with liquid starter fertilizer.

TRANSPLANT WATER: Use 1 to 2 quarts per acre (2.2 to 2.4 liters per hectare) with transplant water.

SOAKING SEEDS: Use 1 quart per 100 gallons (1 liters to 400 liters) of water just before planting.

SIDEDRESS APPLICATION: With row crops, apply with fertilizer on both sides of the row, at 1 quart per acre (2.2 liters per hectare).

FOLIAR SPRAY: Spray on young plants at 1 quart per acre (2.2 liters per hectare) in conjunction with foliar nutrients.

TREES, SHRUBS, AND VINES: Apply as a foliar spray with foliar nutrients at rate of 1 quart per 100 gallons of water (1 liter per 400 liters of water) to thoroughly wet leaves, stems and base of plant. Repeat sprays every month.

LAWNS AND GOLF COURSES: Apply each month,1 quart per 10,000 square feet. Can be applied with liquid fertilizer.

IRRIGATION SYSTEMS

FURROW RUN: Dilute with 10 parts water and dribble into water source to distribute the diluted mixture at 2.5 gallons per acre (23 liters per hectare).

DRIP AND SPRINKLER: Dilute with 10 parts water and inject diluted mixture at 2.5 gallons per acre (23 liters per hectare). Repeat every 3 to 5 weeks. Maintain agitation of the irrigation solution being supplied to the injector pump. CHARGE 12% can be applied through drip, center pivot, permanent solid set or self-propelled wheel move irrigation systems equipped with automatic shut-off devices and valves to prevent back flow into the water source. Interlocking controls should be installed between the water pump and the injector pump so that both pumps stop if either one should fail.

ORNAMENTALS: Use **CHARGE 12%** on containers, bench, or seed-gown ornamentals in greenhouses or outdoor nurseries and on ornamentals grown for indoor and outdoor landscaping. Apply 8-16 oz. in 100 gallons of water.

MIXING INSTRUCTIONS: Use the following mixing order: (1) Water (2) CHARGE 12% (3) Pesticide/Fertilizer. CHARGE 12% is compatible with most fertilizers and pesticides. Always conduct a jar test when using new or untried combinations.
