### STORAGE AND DISPOSAL

Micro-Plus products are complexed with medium corrosivity. It is recommended that Micro-Plus be stored in fiberglass, polyethylene or polyolefin. We recommend storing pails a maximum of three pails high. Do not stack pallets. Store container tightly closed in a cool/well-ventilated dry place protected from sunlight above 40°F. Do not allow container to freeze. Store locked up. DISPOSE of contents/container at a permitted facility or as advised by your local regulatory authority. Do not contaminate water, food or feed by storage or disposal. Do not apply directly to areas where surface water is present, or to intertidal areas below the mean high water mark. ## GENERAL INFORMATION

---

**MICRO-PLUS** complexed micronutrients are for soil and foliar\* application. They are readily available and may be rapidly absorbed by the root system or foliage.

**MICRO-PLUS** complexed micronutrients are formulated to be used in Stoller liquid fertilizers (NITRO-PLUS, URA-CAL, FOLIZYME) and Nitrogen solutions. When used with polyphosphate containing fertilizers, dilute with nitrogen solution before addition. Broadcast or row applications are acceptable, although greater efficiency may be expected from row applications. Micronutrient deficiencies usually occur when plants are small; therefore, micronutrients should be added to the fertilizer at or before planting.

## RECOMMENDED USES

---

Soil application of **MICRO-PLUS 5% IRON** can be incorporated in liquid fertilizer or applied separately. **MICRO-PLUS 5% IRON** can be coated on dry blend fertilizer to control dust in the blend plant and supply needed micronutrients. Contact Stoller Enterprises, Inc. to receive the necessary equipment and operating instructions.

Maintenance Application: 1 quart per acre

Moderate Micronutrient Deficiency: 0.5 to 1 gallon per acre

Heavy Micronutrient Deficiency: 1 to 2 gallons per acre

Apply the following rates if you do not have a soil or leaf analysis:

If you have a soil or leaf analysis recommendation, apply **MICRO-PLUS IRON 5% IRON** at the following rates:
