## RECOMMENDED USES

---

### **FOR SOIL APPLICATION:**

**NITRO PLUS 9** can be broadcast spray applied pre-planting or pre-emergence to the soil to supply needed nitrogen to the crop. Can be combined with 28% or 32% UAN to meet nitrogen needs of the crop to be grown. Rate will vary by crop needs and yield targets. Consult a certified crop advisor, agronomist, university crop, extension publication or apply according to recommendation approved in your nutrient management plan.

### **FOR SIDE DRESS APPLICATION:**

**NITRO PLUS 9** can be used as nitrogen and/or calcium source for side dress application to any crop requiring nitrogen or calcium. Can be combined with 28% or 32% UAN to meet nitrogen supply need by the crop. Consult a certified crop advisor, agronomist, university crop, extension publication or apply according to recommendation approved in your nutrient management plan.

**\*\*DO NOT mix with any fertilizer containing phosphorus, as precipitate may occur.**

**MIXING INSTRUCTIONS:** Follow this mixing order – (1) Water or 28% or 32% UAN (2) **NITRO PLUS 9**. **NITRO PLUS 9** will disperse in water, 28% UAN or 32% UAN, with some agitation.

**\*\*DO NOT mix **NITRO PLUS 9** with other crop chemicals without manufacturer's approval.**
