STOLLER®PRO IRONPRO PLUS 12-0-0 is available and absorbed by the leaf surface or the root system.

DIRECTIONS FOR USE

STOLLERPRO IRONPRO PLUS 12-0-0 can be applied as a foliar application, and through flood, drip sprinkler, overhead, pivot and micro irrigation systems. Apply the recommended amount in a volume sufficient to provide uniform coverage.

FOLIAR APPLICATION RATES:

- For best results apply as a foliar spray in the early morning when temperatures are lowest.
- Do not apply water for 4 to 6 hours to ensure plant uptake.
- For severe iron deficiencies apply the highest rate.
- Application on cool season turf should be made when temperatures are below 80 degrees Fahrenheit.
- Turf grasses: Apply 2 to 6 fl. oz. per 1000 sq. ft., 7 to 14 days throughout the growing season on all types of turf.
